Accordingly, all the Deputy Commissioners are requested to issue necessary directions to all the Principals of KVs under their jurisdiction to take appropriate measures for viewing of the said programme. In this regard, the following may also be ensured in each KV:

1. Arrangement of projectors and TVs may be ensured in each KV along with DTH/Virtual Connection & continue & uninterrupted electricity, so that all students, teachers and staff of the KV can view/hear the live address & interaction of Hon'ble Prime Minister of India.
2. Apart from TV broadcast, viewing facility may also be arranged through Edusat and also on Internet access devices (computer/laptops/mobiles etc.) wherever needed. Web link will be shared separately.
3. As this program would focus on some of the key questions related to examination, you are requested to ensure maximum participation of students, teachers, staff & other stakeholders.
4. Social media handles/website of KVs & ROs are to be updated regarding PPC-5.0 and best Photos/Videos are to be uploaded after checking of the content.
5. Data of students, teachers, staff, parents and other stakeholders who viewed the PPC-5.0 on 1st April, 2022, be shared immediately in Google sheet after said programme is over as enclosed in **Annexure-I**.
